# XXT.Token

XXT.Token (XXT) is a cryptocurrency designed to be the means of payment and integrate the entire adult entertainment ecosystem.

Our objective is to use the token as currency to pay and receive for services and products, integrating customers, stores, hotels, sex-shops, motels, suppliers, adult live stream, bars and nightclubs. Facilitating and encouraging sensuality and eroticization of people who seek to improve and make their sex life more pleasurable, both in Brazil and in all countries where it is traded.

Developed in Brazil by Brazilians. We are considered one of the happiest and most optimistic people in the world. And certainly, the Brazilian sensuality and beauty is an important factor in this joy.

We are all tired of pandemics, isolation, politics and so many other things, which little by little, make people less sensitive and less sensual. Our token wants to rescue people's sensual and sexual pleasure, no matter their sex, gender, color, race, ethnicity, height or physical form.



Many motels, sex-shops, bars, clubs, nightclubs, which were closed until recently, are starting to reopen. We want to promote, maintain and expand jobs in this sector, through the creation of a unique, powerful and sensual means of payment. We intend to be the currency of the adult entertainment sector, stimulating the trade of products and services throughout Brazil.

Our team is working around the clock, with the objective of making people feel more wanted, more ardent, hotter, more "calientes", through partnerships with companies and people in the adult entertainment sector, all interconnected through the adoption of the token as the means of virtual payment.

People will be able to buy our token as a long-term investment (holders) or to consume products and services. With the appreciation of XXT.Token, customers will have more purchasing power, and retailers and suppliers will also have a significant increase in their sales and revenue. With that we will have a virtuous circle, where people will have more money to spend on their pleasures. And, consequently, there will be tremendous growth in this sector that is so important today.

Investors and holders will be recognized as people who believe in and invest in the Blockchain's sexiest cryptocurrency.

We also intend to increase security in commercial transactions, through the speed, ease and convenience of transacting cryptocurrencies directly between both B2C and B2B electronic wallets. Using the XXT application that will be developed later.

One of the main goals of our token is to stimulate people's sensual and sexual well-being, regardless of sexual preference or orientation, including, but not limited to, heterosexuals, homosexuals, bisexuals, pansexual and other denominations.



Investors and holders will be recognized as differentiated customers at XXT.Token stores and partners.

We are going to launch a trading house for training in the financial market, including but not limited to cryptocurrencies, Forex, binary options, index and dollar on B3. All this associated with leisure and fun to decompress the stress of the financial market.

Investors will be able to participate in free events such as poolside barbecues, among other events that will be announced in the future.

Our team will do an intense work in support of NGOs and other entities that fight violence against women and femicide. We consider this type of crime inadmissible and will dedicate effort, donations and actions in support of this cause.

# Violence against women and femicide

The United Nations defines violence against women as "any act of gender-based violence that results or may result in physical, sexual or mental harm or suffering to women, including threats of such acts, coercion or arbitrary deprivation of liberty, whether in public or private life".

Unfortunately, we are currently witnessing a considerable increase in violence against women and femicide. This crime, which should be considered heinous, is committed by partners, partners, boyfriends, husbands and even strangers.

Five types of domestic and family violence against women are foreseen in the Maria da Penha Law: physical, psychological, moral, sexual and patrimonial – Chapter II, art. 7, items I, II, III, IV and V of Brazilian law:

1. **PHYSICAL VIOLENCE**
  - a. Understood as any conduct that offends the woman's bodily integrity or health.
2. **PSYCHOLOGICAL VIOLENCE**
  - a. Any conduct that: causes emotional damage and decreased self-esteem is considered; harm and disturb the full development of women; or aims to degrade or control your actions, behaviors, beliefs and decisions.
3. **SEXUAL VIOLENCE**
  - a. This is any conduct that constrains witnessing, maintaining or participating in unwanted sexual intercourse through intimidation, threat, coercion or use of force.
4. **PROPERTY VIOLENCE**
  - a. Understood as any conduct that configures retention, subtraction, partial or destruction of its objects, instruments of work, personal documents, assets, values and rights or economic resources, including those intended to satisfy its needs.
5. **MORAL VIOLENCE**
  - a. Any conduct that constitutes libel, defamation or insult is considered.

We will work together with entities and non-governmental organizations (NGOs) to help fight all types of violence against women. We will promote joint marketing campaigns, combined with donations made with XXT.Token.

With this, we want to raise awareness among the population and establish a flow of concrete actions against this type of crime in Brazil and abroad where our token is traded.

# Tokenomics

We are a decentralized token in the BEP-20 (Binance Smart Chain) standard).

The token will be used as payment currency for commercial transactions between investors, and the entire ecosystem of partners and companies that use it. And for everyone who wants to participate in paid trading house events.

And for this to be functional, the number of tokens released after the initial burn will be limited. This way, the value of XXT.Token tends to go up, creating a strong and easily calculable currency to pay for everyday things.

The launching and trading will be initially done through PancakeSwap, which is a DEX – Binance Smart Chain-base Decentralized Exchange, that is, a decentralized Binance Exchange, aimed at trading the BEP-20 standard token (currency).

Holders, who buy and not sell the currency, will also be rewarded with a percentage charged on all buy and sell transactions. The more tokens that are kept in your wallet for longer, the more you will gain from every transaction.

## Deflationary Mechanism + Earning Potential

XXT.Token (XXT)

All transactions (buy / sell / transfer) will be taxed at 10%, with the following distribution:

- 1.0% for all holders, creating an incentive to keep their tokens in their wallets
- 1,0% burned in every transaction
- 4,0% for automatic generation of liquidity (pool)
- 3,0% for expenses and marketing wallet
- 1.0% for the developers

## Supply and Distribution of Tokens

2% distributed to developer 1

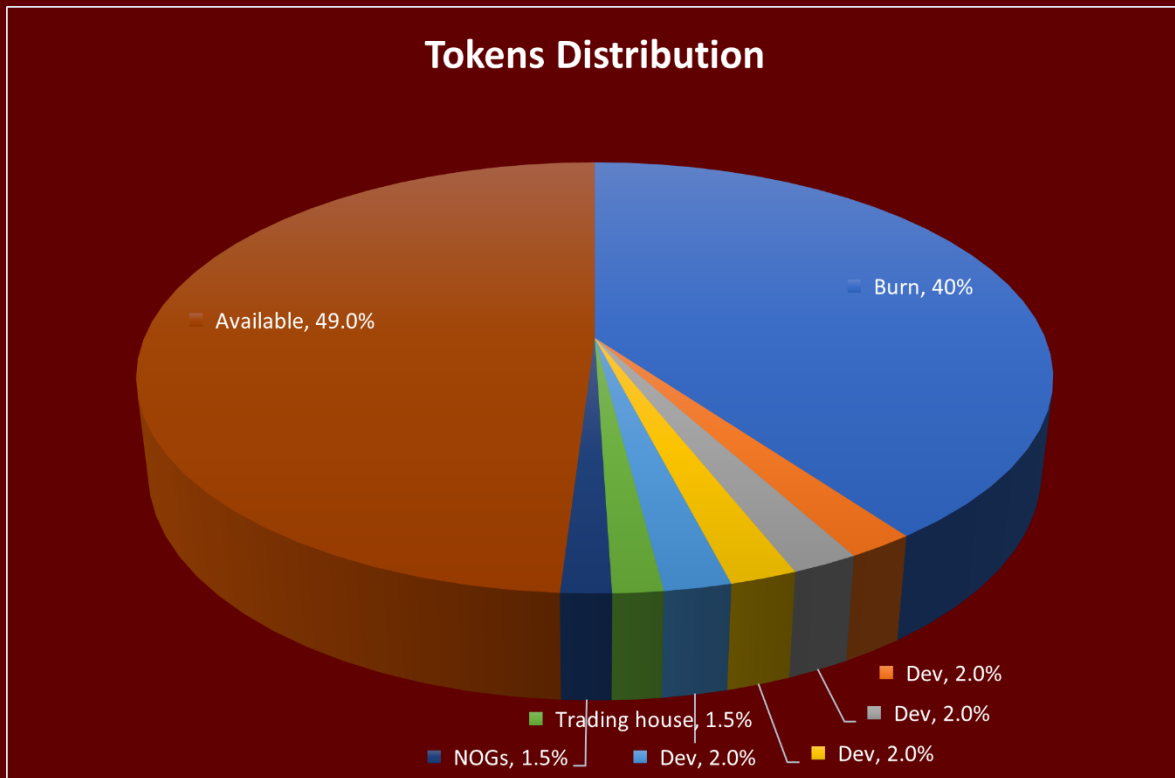

## Pre-sales

There will be no pre-sales, because most of them end up favoring only those who bought before. Once released, pre-bought whales dump their wallets, throwing the price down. As a result, many investors lose money, and the token is unlikely to recover in the medium and long term.

Thus, our token will have a fair launch, without pre-sales and open to everyone, in an equal process for all investors.

# Future XXT

## XXT Trading House

XXT Trading House will be an exclusive meeting place for investors and holders. Our team will host a variety of free events, including but not limited to barbecues, lectures, parties and more, so that investors can enjoy the benefits of their investments, recognize and be recognized as investors.

In addition to the free events, our team will promote at the Trading House virtual and on-site training, trading rooms and other activities, which will be paid through our token. In this way, we will promote an expansion of the ecosystem of companies and investors that use our token for commercial transactions.

## Motels

Our token intends to integrate all suppliers that participate in the supply chain of services in the motels sector, from employees to suppliers, including food, security, transportation, marketing and advertising.

The use of a strong currency as our token, will have a strong impact on the profitability of companies, as well as a better balance between income and expenses.

The motel sector was severely affected during the pandemic, as well as other segments. The implementation of safety and hygiene measures has considerably increased the costs of the motels. Our token comes to minimize the impact of this increase in operating costs, allowing for the recovery of profitability, as well as promoting the opening of new motels.

Holders who pay for the motel with the XXT.Token will receive an extra hour free of charge during their stay at the motel.

Additionally, holders will be awarded a free upgrade to a motel suite. For example, if you choose a simple suite, you will automatically be upgraded to a whirlpool suite.



## Sex-shops

Sex-shop stores were also forced to close their doors, causing layoffs and even closure of many companies. The stores that managed to reduce their costs and remain open saw their turnover drop by at least 60%. It is estimated that with the adoption of our token, the sex-shop sector will be able to recover a good part of this revenue in the first quarter of its full implementation.

Our team intends to encourage the sale of accessories for adult entertainment, through the appreciation of its currency, associated with marketing campaigns aimed at the emotional and sensual well-being of the population. No one will be forgotten, as we will promote the sensual inclusion of heterosexuals, homosexuals, bisexuals, pansexual and other denominations.



Holders can be served by appointment, having at their disposal an exclusive seller, to receive all the attention and affection that a true holder XXT.Token deserves and desires.

In addition, they will also be able to participate in classes and live demonstrations of the latest releases of accessories for adult entertainment, through sessions promoted by the partner sex-shops of XXT.Token.

## Nightclubs

This is a sector that must re-start its activities with force as soon as the restrictions of the pandemic are relaxed. The isolation imposed on all of us has caused emotional, sensual and sexual discomfort in most men and women.

Our token will be the real-time payment currency in nightclubs and nightclubs.



Customers and consumers will only need to make a simple transfer of tokens from their electronic wallets to the bartender. All holders who make at least one payment transaction with our token in nightclubs and nightclubs will receive a free exclusive complimentary drink.

In addition, holders won't need to get in line, if any, in bars and nightclubs. It will only be enough to present the XXT.Token in their wallets, to be identified as a holder of our token, and entry will be immediately allowed.

## App for payments

We want to facilitate the use of our token as an effective means of payment in business transactions from day to day or night to night.



Imagine being in a nightclub and waiting to pay the bill after you've had a few drinks. Entering the wallet code and the amount to be paid can become a challenge...

Therefore, XXT.Token will develop an application that will use QR Code to facilitate payment and receipt business transactions.
